International participation in meetings such the IAF ILAC 2024 Joint Annual Meetings held in Berlin, Germany and 15th AFRAC GA & Meetings held in Johannesburg, South Africa is a key element in strengthening the regional and international affiliations of SADCAS.

In the spirit of promoting stakeholder engagement, SADCAS CEO, Ms Eve Christine Gadzikwa signed a Memorandum of Understanding (MoU) on areas of mutual cooperation with China National Accreditation Service for Conformity Assessment (CNAS) with other four African Accreditation bodies in September 2024. The MoU marks the beginning of a long fruitful friendship between China and Africa.

It has been a momentous and an incredible year for SADCAS, and as the year comes to a close, we wish you a happy and restful holiday!

During the year, SADCAS witnessed an exponential increase in the use of digital networks and platforms which dominated the way we think about work thus, enabling us to undertake tasks onsite and offsite, managing complex data and communicating effectively with our internal and external stakeholders. This digital trend has been at the heart of our efforts as we strive to continue improving efficiencies, providing a superior customer experience and developing great content for our readers. Thousands of people across our 14 Member States that we serve depend on our channels and portals, to stay connected and informed on accreditation issues. In addition to updating our accreditation related policies and procedures, we have maintained a strong presence and visibility to our stakeholders by regularly publishing information on our website and various media platforms. We rose to the challenge, having launched the Digital Transformation Journey in 2023, during the year we relaunched our website which now has a new look. The reliability of the service we provide and the quality of the content we offer defines us.

SADCAS is now in its 16th year of operation and continues to grow in terms of field, scope of accreditation, sectorial coverage, and in terms of geographical diversity. As of 31 October 2024, SADCAS has issued 360 accreditation certificates to 316 accredited facilities in 13 SADC Member States and 2 non-SADC member states: Ghana and Burundi. As of 31 October 2024, SADCAS had cumulatively conducted 295 training courses in most SADC Member States as part of its efforts to develop the capacity of conformity assessment bodies for accreditation.

End Of Year Message From The CEO

As 2024 draws to a close I want to take the opportunity to look back on the year that turned out very well. While it was certainly challenging in many ways, it also showed how resilient and resourceful we are as a company – even in the toughest of times. We can take pride in the fact that the work we did during the year helped companies not only to stay in business but to expand their territories. By being able to demonstrate competency, SADCAS accreditation assisted businesses to open up new market opportunities locally, regionally and internationally.

The multi-economy accreditation body recruited additional manpower during the year in line with its HR Plans to adequately resource all accreditation and administrative support processes and to cope with additional demands.

SADCAS is exploring new opportunities for further development in other relevant areas and during the period under review managed to progress plans to develop the SADCAS Proficiency Testing Scheme. Looking at the growing needs in this area, SADCAS intends to extend its accreditation service to PT providers in the region and also achieve signatory status in AFRAC MRA and IAF MLA for Proficiency Testing (ISO/IEC 17043: 2023). Hence a feasibility study was carried out aiming to assess the practicality and viability of establishing and analysing SADCAS strengths and weaknesses and the existing resources and structures, review the Quality Management System Documentation and the required additional resources for establishing the PT scheme including financial implication, market analysis, technical feasibility, and operational feasibility while adhering to the requirements of ISO/IEC 17011: 2017.

SADCAS recognises the importance of keeping close to its stakeholders and as such, continued to participate in regional and international meetings namely; SADCA, AFRAC and IAF/ILAC. In addition, SADCAS organised a special Annual NAFP Meeting in Johannesburg, South Africa on the 21st November 2024 to update and equip the National Accreditation Focal Points who are the administrative arms of SADCAS in the region to promote the benefits of accreditation. Lastly, let me on behalf of SADCAS extend a heartfelt appreciation to all our valued clients, stakeholders, donors, international cooperating partners, the Board, Management and Staff for your continued support and contribution during the year. We are excited about the opportunities that lie ahead and look forward to working with you again in the coming year.





SADCAS CEO, Ms. Eve Christine Gadzikwa attended the China-Africa Workshop held on the 1st to 11 September 2024 in Beijing, China with SADCAS delegates: Scheme Coordinator- Mr. Victor Mundembe and Communications & Public Relations Officer- Mr. Boniface Badubi. The workshop was held on the sidelines of the Forum on China- Africa Cooperation (FOCAC) Summit held on the 4 to September 2024, under the theme "Joining Hands to Advance Modernisation and Build High-Level China- Africa Community with a Shared Future. To kickstart the China – Africa Accreditation Workshop 2024, Pu Chun, the Deputy Director of the General Administration of Market Supervision and the Director of the National Accreditation Service for Conformity Assessment witnessed the signing of a memorandum of understanding on cooperation between CNAS and five accreditation bodies:

- 1. SADC Accreditation Service (SADCAS)
- 2. South African National Accreditation System (SANAS)
- 3. Nigerian National Accreditation System (NiNAS)
- 4. SOAC (West African Economic and Monetary Union Accreditation Agency - UEMOA)
- 5. Kenya Accreditation Service (KENAS)

The Memorandum of Understanding (MoU) marks the beginning of a long fruitful friendship between China and Africa. Forum on China- Africa Cooperation Beijing Action Plan (2025 -2027) highlighted the establishment of the China-Africa Center for Standardization Cooperation and Research and the China- Africa conformity assessment capacity building initiative. Furthermore, according to the memorandum, CNAS and relevant African accreditation bodies there will be exchange programmes, personnel visits, technical training and seminars. These efforts will strengthen the development of the African quality infrastructure.

The insightful and packed programme was filled with various technical visits and tours to different CABs, which unpacked the CAB operation and implementation of accreditation requirements and experience sharing between the participants.

The technical visit to CAB and workshop at CAB includes a tour in the CAB, CAB introduction of its operation and implementation of accreditation requirements, CNAS introduction of its related accreditation processes and practices, and Q&A and experience sharing among participants. 



Zambia Medicines Regulatory Authority (ZAMRA) National Drug Quality Control Laboratory (NDQCL) celebrates ISO/IEC 17025:2017 Accreditation Status



The Pharmaceutical industry is growing in SADC and use of appropriate pharmaceuticals is central to disease treatment and prevention. However, access to affordable, safe, and quality-assured medicines is uneven in Southern Africa. A lack of standardised legislation for pharmaceutical usage and disparate treatments for diseases currently affect healthcare in the region, creating challenges for workers already under pressure. Accreditation is a critical tool to engender confidence in the industry's testing laboratory to ensure the safety and quality of pharmaceutical drugs.

It was a great pleasure for SADCAS CEO, Ms. Eve Christine Gadzikwa to participate at the momentous occasion of the accreditation certificate handover ceremony for the **National Drug Quality Control Laboratory (NDQCL)** of the Zambia Medicines Regulatory Authority held at their premises in Lusaka. The event was graced by the guest of honour Minister of Health, Honourable Dr. Elijah Julaki Muchima and several senior government officials, management and staff of NDQCL.

The accreditation landscape in Zambia is growing rapidly and the CEO commended the Government of Zambia for its dedication and commitment to strengthening the quality infrastructure in the country. In her speech at the handover ceremony, she underscored that as of 31 August 2024, there were 29 accredited facilities in Zambia including the National Drug Quality Control Laboratory (NDQCL). This is a testament that the Government of Zambia has embraced the benefits of accreditation. She however highlighted that, there is still room for growth in increasing these numbers and urged the Minister of Health, Honourable Dr. Elijah Julaki Muchima to preach the gospel of accreditation in his ministry and beyond.

The accreditation of the National Drug Quality Control Laboratory (Pharmaceutical Drug Testing) will strengthen Zambia's regulatory capacity to ensure that medicines and allied substances being made available to the Zambian people meet the set standards of quality safety and efficacy. Accreditation is also important in ensuring consumer protection in the market by providing quality goods and services in the pharmaceutical industry. Established by Part vii of the Medicines and Allied Substances Act no. 3 of 2013 MASA), NDQCL was established in 2009 under the then Pharmaceutical Regulatory Authority (PRA) which ceased to exist following the repelling of the Law to the MASA. The mandate of the Laboratory is to provide testing and other Laboratoryrelated services to the public and for regulatory purpose. The Laboratory has two Main sections:

- Physical Chemical Laboratory (accredited to ISO/IEC 17025 for the scope)
- Microbiology Laboratory

The Laboratory Quality Management System was established in 2013 with the aim of meeting the needs of stakeholders and attaining **ISO/IEC 17025:2017** accreditation and WHO prequalification. The NDQCL story highlights the importance of accreditation in facilitating global trade, this accreditation would strengthen NDQCL functions in providing quality control functions and providing factual and accurate advice to the Ministry of Health.



NDQCL has been accredited by the SADC Accreditation Service (SADCAS) for its Testing Laboratory on the scope of **PHARMACEUTICAL PRODUCTS (Chemical Analysis)**. NDQCL has been granted the unique accreditation number PHAR 006 indicating that NDQCL is now an internationally recognized Testing Laboratory. The facility is accredited in accordance with recognized International Standard **ISO**/ **IEC 17025:2017.** The accreditation certificate was issued on 19 September 2024 and is valid for five (5) years, with an expiry date of 18 September 2029. Accreditation plays a pivotal role in supporting global trade by removing the technical barriers to trade (TBTs).

Pharmacy and Medicines Regulatory Authority Malawi grantead ISO/IEC 17025:2017 Accreditation

In December 2024, the SADCAS CEO, Ms Eve Christine Gadzikwa participated in 2 accreditation handover ceremonies; **Pharmacy and Medicines Regulatory Authority – National Medicine Quality Control Laboratory** that was accredited to ISO/IEC 17025: 2017 and Tanzania Bureau of Standards - Product Certification Services that was accredited to ISO/IEC 17065:2012 in Malawi and Tanzania respectively.

PMRA has been accredited by the SADC Accreditation Service (SADCAS) for its Testing Laboratory in the scope of Pharmaceutical Products (Chemical Analysis). PMRA has been granted the unique accreditation number PHAR 004 indicating that PMRA is now an internationally recognized Testing Laboratory. The facility is accredited in accordance with recognized International Standard ISO/IEC 17025:2017.

At the certificate handover ceremony held in Lilongwe, Malawi on 4th December 2024 at the new National Medicine Quality Control Laboratory facilities in Lilongwe Malawi, the Honourable Khumbize Kandodo Chipondo, MP Minister of Health, highlighted the importance of the accreditation in safeguarding the health and safety of consumers as well as meeting minimum regulatory requirements set by the regulator. She emphasised that, in addition to maintaining credibility of test results and assurance of competency of the laboratory, other critical benefits of the accreditation are also safety, efficiency and quality all medicines embedded in the process for better patient care outcomes. She further highlighted that; Malawi no longer needs to depend on outsiders to provide accredited testing laboratories to assure the credibility of test reports because SADCAS has provided that third party assurance in terms of confirming the competency of the NMQCL. She thanked SADCAS for supporting the facility throughout the entire process which has culminated in attainment of the accreditation to international standards. She went further to reiterate that, the Ministry of Health in Malawi will provide full support to the facility to ensure that all the tests undertaken by NMQCL are accredited so that PMRA and the government procurement agency have confidence in the pharmaceutical products and medicines in terms of quality, safety and efficiency. The PMRA Director General Mr. Mphatso Kawaye greatly appreciated the professionalism of SADCAS and assured the CEO that he will work tirelessly to maintain the highest standards to enhance trust and credibility, international recognition and collaboration of PMRA with other similar accredited organisations in the Region with whom NMQCL undertakes Inter-Laboratory Comparisons (ILCs). He concluded his remarks by underscoring that, through comprehensive assessments which are undertaken by SADCAS, the laboratory's processes, testing methodologies, quality management system and staff competency will continue to be verified against the requirements of the standard. "We are excited about this huge milestone in the Pharmaceutical value chain which will contribute to economic development of Malawi towards agenda 2063".

Abdallah congratulated Tanzania Bureau of Standards Certification Services for being Accredited by SADCAS and the impact this accreditation will provide in terms of enhancing trust in the market and promoting trade in the East Africa Region.

"The accreditation landscape in Tanzania is growing rapidly and I would like to commend the Government of Tanzania for its dedication and commitment to strengthening the quality infrastructure and reaping the benefits of accreditation. As of 31 October 2024, there were 100 SADCAS accredited facilities in Tanzania including TBS- Product Certification Services. This is a clear demonstration that Tanzania has embraced the accreditation. Tanzania accreditations accounts for 32% of facilities accredited by SADCAS in the SADC region and spotlights the sheer dedication and commitment to strengthening the quality infrastructure in the country. Well done Tanzania for being the forerunner in terms of accreditation in the SADC Region!", the SADCAS CEO said in her handover speech as she congratulated Tanzania Bureau of Standards Certification Services on attaining accreditation of the Product Certification Services. In her remarks on the momentous occasion the SADCAS CEO, Ms Eve Gadzikwa highlighted that, this accreditation is one of many accreditations by SADCAS. She highlighted that 9 Test laboratories, 9 Management Systems and 1 Product Certification are all accredited by SADCAS bringing the total number to 19 TBS accreditations. She congratulated TBS for the noble achievement and its contribution in supporting the private sector and reiterated that TBS-Product Certification Services has been accredited by the SADC Accreditation Service (SADCAS) for its laboratory in the scope of Product Certification. She went on to explain that, TBS Product Certification Services has been granted the unique accreditation number PROD- CERT 003 indicating that TBS Product Certification Services is now internationally recognized. The facility is accredited in accordance with recognized International Standard ISO/ IEC 17065:2012 and ISO/IEC 17067: 2013.

She elaborated that this accreditation by SADCAS is for the following products; Carbonated Soft Drinks,

Packaged / Bottled drinking water, Beer, Ready to Drink non -carbonated, non-alcoholic beverage, Wood poles and blocks for power and telecommunication on lines, Petroleum jelly for cosmetic industry, skin care creams, lotions and gels, cement, steel for re-enforcement of concrete (high grade ribbed bars), steel for re-enforcement of concrete (low grade steel), Polyvinyl chloride insulted cables (voltages up to 450/750). Such a huge range of products means that, the Government of Tanzania will be able to reap the benefits of accreditation of Tanzania Bureau of Standards Certification Services by providing assurance to its customers in the East African Region and beyond.

The private sector representatives who attended the ceremony reaffirmed their commitment to maintaining their accredited certification which is helping them access new markets, reach their targets and promoting trust in the credibility of their products.

African Accreditation Cooperation (AFRAC) a cooperation of is accreditation bodies, National Accreditation Focal Points (NAFPs) and stakeholders with an interest in accreditation matters. At the AU Conference of Ministers of Industry (CAMI) held from 10 - 14 June 2013, the Pan-African Quality Infrastructure (AFRAC, AFRIMETS, ARSO and AFSEC) was recognised as the continental platform for all matters related to standardisation, metrology, accreditation and conformity assessment.



SADCAS Advisory Committee for IBAS – Zimbabwe Holds 14th Meeting



The 14th meeting of the Zimbabwe Advisory Committee for the SADCAS Inspection Bodies Accreditation Scheme (IBAS - Zimbabwe) (AC.01) was held on 24 October 2024 remotely for the fourth time.

The Advisory Committee is a fundamental and vital component of operating a technically relevant accreditation system. The role of the Advisory Committee is to provide technical guidance on all matters relating to accreditation within a specific field of expertise, to ensure technical integrity of the accreditation processes as well as to guide technical policy and provide important support in technical matters to the assessment process. SADCAS has clearly defined terms of reference, registration and responsibilities of Advisory Committees in procedure SADCAS AP 11.

The 14th IBAS Zimbabwe Advisory Committee meeting was well-attended by 10 of the 15 members, a 67 % participation which is over the 25 % quorum required for an advisory committee meeting.

The main purpose of the 14th Advisory Committee Meeting was to receive updates on:

- Developments at SADCAS;
- Terms of Reference Registration and Responsibilities of Advisory Committees;
- Revised SADCAS documents;
- Developments at International Level;

- Update on SADCAS TR / AFRAC documents under development
- Identification of areas requiring technical supporting documents.

The meeting kicked off with welcoming remarks from the SADCAS CEO Ms Eve Christine Gadzikwa who gave a brief presentation on Updates on Developments at SADCAS. Mrs Pinkie Malebe, SADCAS Technical Manager then

Mr Mundembe requested the meeting to take note of the following:

- As part of revision of ISO/IEC 17020, SADCAS has shared, for possible comments from the AC, CD for ILAC Comment (17 June 2024); ANAB WEBINAR on Committee Draft of ISO/IEC 17020 (25 August 2025); Now with the DIS under development, SADCAS will share the DIS for comments once available in November 2024.
- On 19 August 2024, AFRAC conducted a training on NDT in the scope of ISO/IEC 17020:2012. Secretariat will request a link with the recording, and share, if availed by AFRAC.
- AFRAC to circulate the draft guidance document on NDT within the AFRAC region for commenting.
- ILAC P15:05/2020 Application of ISO/IEC 17020:2012 for the Accreditation of Inspection Bodies; ILAC G27:07/2019 Guidance on measurements performed as part of an inspection process and ILAC G28:07/2018 Guideline for the Formulation of Scopes of Accreditation for Inspection Bodies, are all due for review now or in the near future. In the case of G27 an ILAC decision is needed about the approach to take, taking account of current revision of ISO/IEC 17020.

The Secretary of the AC Mr Victor Mundembe announced that SADCAS had revised SADCAS F 40d - Checklist ISO IEC 17020-2012 - Checklist for Accreditation of Various Types of Bodies Performing Inspection [Issue 3] to include some editorials. Mr Mundembe also announced that SADCAS AP 12 - Part 2 - Accreditation of Inspection Bodies Operating in the Regulatory Voluntary Area was under revision to make it more generic for all accredited Inspection Bodies. Draft 1, Issue 12 was shared and the AC was invited to comment. The meeting also agreed on the following actions:

- 1. As part of the newly introduced Advisory Committee function of Identification, analyzing and evaluating risk to impartiality on an ongoing basis; the Committee was requested to review SADCAS BP 06 - SADCAS Risk Profile 2024/25, identify any additional risks and submit comments to the Secretariat
- 1. As part of *Targeted Marketing Visits* to Zimbabwe, the SADCAS CEO Mrs Eve Christine Gadzikwa was requested to follow up on engagement with the Ministry of Mines and Mining Development for Zimbabwe with a view to proposing MOU similar to the MOU with NSSA. The Zimbabwe Inspection Bodies were also requested to set up a meeting with the ministry and the NAFP.
- As part of the ongoing review of SADCAS TR 05 Criteria for the Accreditation of Inspection Bodies Performing Inspection in Terms of the Pressure [Issue 4] to align with current practices, new technologies and new legal requirements, following a report from the DWG, the committee requested the Secretariat to submit an editable version of SADCAS TR 05 for the DWG to incorporate comments made during the meeting before circulating to the Committee for review.
- Instead of undertaking an NDT situational analysis (survey) questionnaire the Advisory Committee accepted a proposal for accreditation under the scope of NDT to be undertaken through a voluntary scheme, with collaboration with SANAS.

The timelines for all actions were agreed to be **31 December 2024.**

The 15th Advisory Committee for Inspection Bodies in Zimbabwe will be held face to face, in October / November 2025 at a date to be confirmed, in Harare, Zimbabwe.

The 6th CBAS Advisory Committee meeting was well attended by 9 of the 15 members from 13 countries, a 60 % participation which is over the quorum required for an advisory committee meeting.

The main purpose of the 6th Advisory Committee Meeting was to get an update on:

The CBAS AC Meeting was chaired by Mr Fabian Haufiku from Namibia.

Mr Victor Mundembe, the SADCAS Scheme Coordinator for CBAS and the Secretary of the CBAS updated the committee on the following developments at international level by presenting documents that were shared.

- 2. IAF MD 28 IAF Mandatory Document for the Upload and Maintenance of Data on IAF Database was published on 26 October 2023, with an effective date of 26 October 2024. The deadline has passed.
 - All 5 accredited CBs have activated their IAF CertSearch database accounts. 3 out of 5 accredited CBs have uploaded a total of 296 certifications. The 2 outstanding CBs have compiled their certification data and are addressing the technical challenges together with the SADCAS and the IAF CertSearch technical team and are expected to fully comply soon. The common issue is UNIQUE ID numbers. IAF CertSearch is still working on sectors (IAF codes) which are not compulsory at the moment. At the next assessment of each CB, the assessment team will verify full compliance to IAF MD 28 including confirmation that 100% certification data has been uploaded.
- 3. IAF MD 27 Transition Requirements for ISO 22003-1:2022 was published on 30 August 2023 with an application date of 30 August 2025, transition period of 3 years (36 months) from the date of publication. Members to note that transition assessments for all 3 CBs accredited to FSMS have been planned for November 2024, onsite.
- 4. At the last AFRAC TC meeting held in September 2024, the TC has formed a Product Certification Working Group to be convened by SADCAS

Mr Mundembe also reported revision of the procedure SADCAS AP 12 Part 3 to incorporate requirements of ISO/22003-1.

The AC CBAS meeting agreed on the following actions:

- 1. As part of the newly introduced Advisory Committee function of Identification, analyzing and evaluating risk to impartiality on an ongoing basis; the Committee was requested to review SADCAS BP 06 - SADCAS Risk Profile 2024/25, identify any additional risks and submit comments to the Secretariat
- 2. To participate in their respective National Mirror Committees or otherwise, in the revision of ISO/IEC 17065, ISO/IEC 17067 and ISO/IEC 17024.

The timelines for all actions were agreed to be **31 December 2023.**

The 7th Advisory Committee for Certification Bodies Accreditation Scheme will be held remotely in October / November 2025 at a date to be confirmed.

SADCAS conducts Root Cause Analysis Training for Ministry of Agriculture, Water & Land Reform - Namibia



The ISO/IEC 17025:2017 Root Course Analysis was conducted for the Ministry of Agriculture, Water & Land Reform – Namibia on 25, 28 and 29 October 2024 at the Namibia Institute of Public Administration and Management venue in Windhoek.

The three-day training was organized by Ministry of Agriculture, Water and Land Reform in Windhoek, Namibia. The participants were drawn from the Department of Agriculture, Department of Water Affairs and Department of Veterinary in the Ministry of Agriculture, Water and Land Reform

The participants included Quality Officers, Agricultural Scientific Officers, Senior Agricultural Technician, Hydrologist, Veterinary Technician, and a Chinese Expert for soil on secondment to Namibia. Expectations from the participants included; gaining knowledge and skills on corrective actions, ability to clear non-conformities, ability conduct root cause analysis, ability to close nonconformities.

The exercises included discussions on challenges encountered in implementing ISO requirements related root cause analysis (RCA). Other challenges mentioned included; lack of training on root cause analysis, and not being sure of which root cause analysis tools to use.

An exam was written on the final day and the feedback from the participants included requests for other accreditation related training courses such as Method Validation and Verification, Measurement Uncertainty, Executive Awareness on ISO/IEC 17025:2017 & Risk Management.

SADCAS conducts ISO/IEC 17025:2017 Internal Auditing Training for Ministry of Agriculture, Water & Land Reform - Namibia



The ISO/IEC 17025:2017 Internal Auditing course was conducted for the Ministry of Agriculture, Water & Land Reform – Namibia from 22-24 October 2024 at the Namibia Institute of Public Administration and Management venue in Windhoek. The practical audit session was held at the Agricultural laboratory

The participants were drawn from the Department of Agriculture and Department of Water Affairs in the Ministry of Agriculture, Water and Land Reform. Both the Agricultural and Water laboratories held this training in preparation for accreditation which the laboratories hope to gain soon. A total of eight (8) participants attended this course.

The Trainer invited the participants to introduce themselves and to state their expectations from the training course which included: understanding auditing process and audit principles, improving auditing processes, and helping to have their laboratories gain accreditation.

The training course was interspaced with exercises. The group work were very lively and highly enriching presentations from the wide collection of experiences among the participants. Participants were continuously evaluated throughout the training course and at the end of the training course participants sat for a written examination in an effort to evaluate the effectiveness of the training. A practical session was organized in which each participant was given an opportunity to carry out an internal auditing based on their selected clauses from the checklist and to write down the nonconformities wherever found.

During the closing meeting, the participants indicated that

the module on ISO 17025 standard requirements was a good refresher as some of the participants were previously trained in internal auditing. the participant highlighted that the internal audit training has made them realise the need to use the quality manual and start implementing the management system. The practical audit session at the laboratory gave the participants insight into what is required for them to prepare for accreditation and made the participants realise that accreditation is achievable. The participants indicated that the approach that was used by the trainer and SADCAS to include more of practical sessions was very good. The participant also indicated that the course was very interactive and useful, and that the trainer was constantly engaging the participants. The acting Laboratory Manager gave the closing remarks highlighting that the objective of the training to have better understanding of internal auditing was achieved and asked the participants to work as a team on reviewing and implementing the management system in preparation for accreditation.
