

**AGREEMENT FOR THE USE OF COMBINED  
ILAC MRA MARK AND SADCAS ACCREDITATION SYMBOL**

**PARTIES**

This Agreement is made and entered between the Southern Development Community Accreditation Service (SADCAS), a subsidiary institution of the Southern African Development Community (SADC) and a multi-economy accreditation body established in terms of Article 15 B of the Technical Barriers to Trade (TBT) Annex to the SADC Protocol to Trade. SADCAS is a non-profit limited company incorporated under the Botswana Companies Act Ch. 42.01, situated at Plot 50668/9, Unit 3A Second Floor, Tholo Office Park, Fairgrounds in Gaborone, Botswana.

**(Hereinafter referred to as the "CAB")**

**WHEREAS** SADCAS is authorized to use the ILAC MRA Mark issued by the International Laboratory Accreditation Cooperation (ILAC) and to enter this agreement.

**AND WHEREAS** the CAB wishes to seek permission from SADCAS to use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol for the scopes accredited by SADCAS, and SADCAS is willing to grant such permission on the terms set out in this agreement.

## 1. DEFINITIONS

- 1.1 **Accreditation Symbol:** A combination of the SADCAS Trademark (name and logo), accreditation programme and accreditation identification number.
- 1.2 **Agreement:** Agreement between SADCAS and CAB.
- 1.3 **CAB:** Accredited Conformity Assessment Body.
- 1.4 **ILAC:** International Laboratory Accreditation Cooperation.
- 1.5 **Scope:** Scope of accreditation which is specific conformity assessment activities for which accreditation has been granted.
- 1.6 **Parties:** SADCAS and the accredited CAB.
- 1.7 **MRA:** Mutual Recognition Arrangement.

## 2. CONDITIONS OF AGREEMENT

- 2.1 The ILAC is the owner of the ILAC MRA Mark.
- 2.2 The CAB has non-exclusive and non-transferable approval to use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol subject to its maintenance of its ILAC MRA Membership and SADCAS' membership and observance of conditions and restrictions set out in the agreement with SADCAS.
- 2.3 The CAB applies for permission to use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol, only in conjunction with SADCAS Accreditation Symbol, subject to the terms and conditions set out below.
- 2.4 SADCAS grants to the CAB permission to use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol for the scopes of the ILAC MRA for which the CAB has been accredited by SADCAS from the date of this Agreement subject to the conditions and restrictions as follows:
  - a) The accredited CAB shall only use the ILAC MRA Mark together with the SADCAS Accreditation Symbol in the manner set out in **ILAC R 7** "Rules for the Use of the ILAC MRA Mark", **SADCAS TR 01: Part 1** "Conditions for the Use of SADCAS Mark" and **SADCAS TR 01: Part 2** "Use of Combined ILAC MRA Mark and SADCAS Accreditation Symbol", and in accordance with the scopes of the ILAC MRA for which SADCAS is a Signatory and for which the CAB has been accredited;

- b) The Combined ILAC MRA Mark and SADCAS Accreditation Symbol shall only be used by the CAB established in economies where ILAC MRA mark is registered or where an application for registration has been lodged and registration is pending. Accredited CABs are able to use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol for activities undertaken outside the economy in which they are established;
  - c) The Combined ILAC MRA Mark and SADCAS Accreditation Symbol shall be reproduced using an authorized copy obtained from SADCAS and shall be reprinted according to the specifications as detailed in SADCAS TR 01: Part 1;
  - d) The permission granted to the accredited CAB to use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol are non-transferable and non-exclusive;
  - e) The accredited CAB shall not use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol on any documentation unless SADCAS' Accreditation Symbol and the accredited CAB's name and logo are included on the same displayed page and are of approximately the same size;
  - f) The accredited CAB shall use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol in strict accordance with the instructions, conditions, standards of quality and ILAC Mark as specified in ILAC R 7 and SADCAS Accreditation Mark specifications as specified in SADCAS TR 01: Part 1, at any time and from time to time;
  - g) The accredited CAB shall supply specimens of its usage of the Combined ILAC MRA Mark and SADCAS Accreditation Symbol to SADCAS or ILAC, if requested by SADCAS or ILAC;
  - h) The accredited CAB shall not allow its clients to use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol;
  - i) The accredited CAB shall monitor and take suitable action to control the use of the Combined ILAC MRA Mark and SADCAS Accreditation Symbol and to prevent any incorrect references or misleading use by itself or its clients;
  - j) The accredited CAB acknowledges and agrees that it has no proprietary right, title or interest in the Combined ILAC MRA Mark and SADCAS Accreditation Symbol;
  - k) The accredited CAB agrees to cooperate fully and in good faith with SADCAS and/or ILAC for the purpose of securing or protecting ILAC's right in the ILAC MRA Mark; and
  - l) The accredited CAB further agrees not to challenge directly or indirectly ILAC's right, title or interest in the ILAC MRA Mark.
- 2.5 The Agreement to use the Combined ILAC MRA Mark and SADCAS Accreditation Symbol may be terminated as follows:
- a) At any time by agreement with the parties;
  - b) At any time by SADCAS in the event that the conditions in this Agreement or the terms and conditions of accreditation are not satisfied;

- c) Immediately in the event accreditation is withdrawn from the accredited CAB by SADCAS;
- d) Immediately in the event of the termination of this Agreement for the use of the ILAC MRA or ILAC membership;
- e) Immediately in the event of termination of the Agreement for the use of the ILAC MRA Mark between ILAC and SADCAS; and
- f) By SADCAS duly advising the accredited CAB; or
- g) By the ILAC duly advising the accredited CAB.

2.6 The accredited CAB shall indemnify and save ILAC, its directors, officers, employees and authorized representatives, including SADCAS, from and against any and all claims, liabilities, demands, proceedings, causes of action, costs and expenses (including legal fees as incurred) arising from the breach or default of the accredited CAB under this Agreement.
